

WYNDELLLONG.COM'S TERMS AND CONDITIONS – CUSTOM INSTRUMENTAL

WyndellLong.com custom or re-created music may only be used pursuant to the terms and conditions enforced by Wyndell Long hereby known as "Licensor". By purchasing a custom creation or a re-creation from your original music from "WyndellLong.com" / "Nosleepmusic" you, hereby known as the "licensee" automatically become bound to the terms of this License Agreement. You agree that your paypal payment receipt, bank wire transfer receipt, or photocopied money order will be kept on record and will stand as your signature for this agreement. Terms of this agreement begin on the last day of the month of this transaction and expire according to the type of purchase you made.

Terms and Conditions are as follows:

1. The musical compositions created by Licensor in this agreement are "work for hire" compositions. The licensee will provide his/her own original composition (s) to be re-created by Licensor and the rights of the resulting creation will remain the property of the licensee. You may record, perform, promote, edit (complete audio only, no remixes), and sell with the created musical composition (s) as long as you adhere to the rules of "synchronization" (vocals applied to instrumentals, see section 5).

2. A right to use Licensor's re-created music is granted to the original end-user of the product (Licensee) and is NOT transferable to any party. This licensor grants the Licensee the exclusive right to use the created music so long as ADDITIONAL AUDIO AND VOCAL PERFORMANCES are recorded against and with the licensor's compositions herein known as "synchronization" (your vocals on my tracks), and for NO other use unless a specific multimedia license has been requested and granted. You may not rearrange, remix, or edit Licensor compositions without written permission.

Music used without synchronization (your vocals added to the instrumentals) in any form is NOT permitted under this license. If you have intentions of using WyndellLong.com compositions without the act of synchronization, you MUST adhere to the terms under Section 5.

3. It is specifically understood and agreed that Licensor does not acquire any ownership rights or any underlying copyrights of the licensee's music or words. The Licensee retains all rights, title and interest in the music re-created by the licensor, including all copyrights belonging to the original copyright holder. The Licensor will claim performance rights income in the event the created work (s) are played in such venues or broadcast mediums where performance rights income is collected. The Licensor will claim 30% of the performance rights income via ASCAP for the work defined in this agreement only.

4. The Licensor expressly FORBIDS resale or other distribution of re-created compositions bound to this agreement, either as they exist OR any modification thereof. You CANNOT sell, loan, rent, lease, assign, remix, rearrange, or transfer all OR any of the products sold to another user or 3rd party (example - record label, another production company or producer), or for use in any competitive product without written consent by Licensor.

5. Use of the licensor's compositions in isolation (without synchronization of vocal performances) is not permitted without obtaining a special Multimedia license directly from WyndellLong.com. If the licensee is interested in using the composition for use in Radio Broadcast, Commercial Advertisement, Television Broadcast, Video Games, Internet, On-Hold & In-House Background Music, or Film Soundtracks as a instrumental you must contact the Licensor directly in order to be granted such a License.

6. The Licensee may sell with the completed work via this agreement in any format so long as it is a independent venture with no 3rd party involved. You are required to report your annual sales bi-annually. You are also required to report any promotional work you are doing.

7. You agree to supply Licensor at least 2 copies of each recording you make using Licensor's music. This can be delivered on audio CD or mp3 (192 kbps or over). This also includes mp3 id's & cd-r duplications. This must be followed at all times. You must submit your barcode number if you have one as well. All productions you make that include Licensor's re-created music must include the information below.

This agreement covers all works purchased pertaining to Licensor and the exclusive user.
